The Scottish Curling Trust was set up in 2006 to encourage and actively promote public participation in curling; to preserve, conserve, interpret and display the arts, heritage and culture of the sport of curling; and to make provision for disabled people and those who are impaired or have special needs to introduce them to and assist them in their enjoyment of curling. The Scottish Curling Trust works alongside The Royal Caledonian Curling Club to achieve these aims.



Leaving a gift in your Will to the Scottish Curling Trust will make a huge difference to the work we do. Here are just a couple of the projects we have been involved in.

Over the last few years the Scottish Curling Trust has part funded a Development Officer at The Royal Caledonian Curling Club with a disability remit. The aim of this position is to help increase the number of people with disabilities participating in curling, improve access to physical activity and promote social interaction and inclusion. Marked progress has been made in increasing the number of disability clubs and members, opportunities for social and competitive events and developing pathways and structures for disabled people to participate and succeed in the sport.

The Scottish Curling Trust organised the successful fundraising campaign for the Charles Lees painting 'The Grand Match at Linlithgow Loch' (1849) which has been described as one of the most important sporting paintings of the period and for curlers perhaps the most iconic image in the world. The restoration appeal successfully reached its target and the 96" x 60" oil on canvas was beautifully restored and is now on public display at the Scottish National Portrait Gallery in Edinburgh.



## Why William left us a gift in his Will

William Roy was a well-known and admired curler and his membership with The Royal Caledonian Curling Club dated back at least 64 years to 1948. The trustees of his Will opted to bequest a gift to the Scottish Curling Trust in memory of his life.

A donation of £20,000 was gifted to the Charles Lees Restoration Appeal, a campaign to save Lees' greatest masterpiece 'The Grand Match at Linlithgow Loch' (1849). This generous gift ensured that urgently needed restoration work was carried out to return the painting to public display to be enjoyed by future generations here in Scotland and in the wider global curling community.


The Trustees also gifted £10,000 for the creation of a new fund to help young and talented curlers commit to the sport and achieve their ambitions. The Scottish Curling Trust proposed the William Roy Fund to make grant awards to eligible recipients on a yearly basis. This was agreed to be a fitting tribute to William Roy's own dedication to curling and encouragement of young people in the sport.



## Why Liz left us a gift in her Will

Liz (name changed) is a longstanding member of The Royal Caledonian Curling Club and has been involved in the sport at her local ice rink and, to a certain degree, across the country. She has other leisure interests but has a passion for curling on and off the ice, as a player and spectator; she has also developed an interest in the history of the game in recent years. Having derived so much pleasure from the sport she has decided to leave something to the Scottish Curling Trust in her Will. In her words, she outlines why she decided to do this:

"I have really enjoyed playing the game for over 30 years and love to see the joy new people get when they try and then get hooked on curling. I am lucky to have made many great friends through the sport and would like to see future generations having the opportunity to enjoy curling as I have done. I also believe that it is important to preserve the history of our uniquely Scottish game, and want to support the Scottish Curling Trust in doing this through cataloging, restoring and displaying a national collection of artefacts for future generations to enjoy. It was very easy to add a clause to my existing Will that instructs the executors to apportion a fixed amount to the Scottish Curling Trust."



## How do I leave a legacy gift?

There are three main types of legacy: Residuary, Pecuniary and Specific.

A **Residuary** legacy is a percentage of your Estate after expenses and other gifts have been deducted.

A **Pecuniary** legacy is a gift of a specified amount of money.

A **Specific** legacy is a specific item such as property or curling artefacts.

If you decide to leave a gift to the Scottish Curling Trust in your Will then it is important to give your solicitor our correct details to ensure your wishes are met. These are:

## Can I add the Scottish Curling Trust to my existing Will?

If you have already written your Will and would now like to include the Scottish Curling Trust then this can be done by adding a codicil to your existing Will. This is just a short paragraph (clause) and we have provided some wording overleaf.

We advise that you consult a solicitor when reviewing your Will. However you can return this codicil to your solicitor to include the Scottish Curling Trust in your Will. Your solicitor will then ensure any future amendments include your wishes for the Scottish Curling Trust.
